

Terms and Conditions of participation for the Fronius campaign: "Winter competition 2024 – Best Fronius systems in the BENELUX"

1. Organizer

The organizer of this competition is Fronius International GmbH, with headquarters in A-4643 Pettenbach, Froniusstrasse 1, Austria, hereinafter referred to as Fronius. Participation in the Fronius International GmbH campaign is free of charge and is governed solely by these terms and conditions.

The competition to win a Fronius gift package is in no way sponsored, supported or organized by external parties.

For reasons of readability, the neutral or masculine form of the term "participant" and "winner" is largely used in these conditions of participation. Of course, the corresponding female form is always meant as well.

Errors and misprints excepted.

2. Procedure of the campaign and sweepstake

Every participant who sends the completed online form to Fronius from 1st December 2024 and before January 31st, 2024 and accepts these conditions of participation agrees is eligible to participate. After the end of the promotion, winners are selected and will then be notified with up to 1 week delay. The prize will then be shipped to the winners. Participation includes that the submitted photos, media and information may be used by Fronius in internal and external communication.

3. Participation and eligible participants

Participation in this campaign is free of charge. To participate in the sweepstake, the conditions of participation must be accepted. Participation is only possible within the participation period. Participation in the sweepstakes is possible multiple times per customer (multiple systems can be submitted).

All natural persons aged 18 and over who are resident in one of the following countries are eligible to participate:

- Belgium, Netherlands, Luxembourg



Furthermore, the competition is limited to employees of Fronius installer companies or employees of Fronius Sales Partners.

Participant in the sense of the competition is the natural person who has accepted the conditions of participation. Should a participant have limited legal capacity, the consent of his/her legal representative is required.

Participation does not give rise to any legal claims and Fronius accepts no liability.

4. Procedure of determining the winner

Winners are selected by Fronius as the competition organisers. Criteria influencing the decision are: Type of PV system submitted, photo quality, quality of submitted information, uniqueness and relevance of the system for Fronius marketing purposes.

5. Exclusion from the competition

Employees of Fronius and other persons involved in the design and implementation of this competition are excluded from participation.

Fronius expressly reserves the right, at its own discretion, to exclude persons from participation if there are justified reasons, for example (a) in the event of manipulation in connection with access to or implementation of the prize draw, (b) in the event of violations of these conditions of participation, (c) in the event of unfair conduct or (d) in the event of false or misleading information in connection with participation in the prize draw.

6. Winning, notification and transmission of the prize

The winner agrees to be named as the winner in the advertising media used by Fronius, in particular websites and social media platforms.

7. Termination of the competition

Fronius expressly reserves the right to terminate the competition at any time without prior notice and without giving reasons. This applies in particular to any reasons that would disrupt or prevent the competition from running as planned. The competition will be terminated prematurely in particular if proper execution cannot be guaranteed for technical (e.g. errors or manipulation affecting the hardware and/or software used) or legal reasons.

8. Privacy

For participation in the campaign, the processing of the participant's personal data is necessary. These are in particular the personal data collected from the participant himself, such as first name, last name, Company Name, Company Adress, Country, Phone Number and email address. For the purpose of the competition and for future use in Fronius marketing, the participants also provide data referring to their experience with Fronius products, a PV system they have installed, and associated photos. By uploading this material, the participant allows Fronius to use them in all internal and external communication. The participant himself/herself is responsible for the correctness of his/her data.

Fronius processes personal data in accordance with the statutory provisions and the European Union's General Data Protection Regulation (GDPR). The data will be used and processed by Fronius and/or its subsidiaries, agencies and contractors (i.e. Technical Advisors). The processing of the data when participating in the campaign is carried out by FRONIUS INTERNATIONAL GmbH, if necessary also with the involvement of its subsidiaries and local partners (i.e. Fronius sales partners and Fronius Technical Advisors).

The personal data that is transferred to us during participation is processed for the implementation of the campaign. The legal basis for this is the fulfilment of this contract (Art. 6 para. 1 lit b) GDPR) in order to be able to carry out the campaign and the request for information by the participants, as requested in the contact form.

In the event of a win, the winner, by accepting these terms and conditions of participation, agrees to the publication of his/her name in the advertising media used by the organizer. This includes the announcement of the winner on the Fronius website and its social media platforms.



In connection with their personal data, every participant has the fundamental right to information, correction, deletion, restriction, objection, revocation of consent, data portability and to lodge a complaint with Fronius at dataprotection@fronius.com or with the Austrian Data Protection Authority, Barichgasse 40-42, 1030 Vienna.
